1. You understand that price of fund(s) and investment return posted on BOOM website may go down as well as up and is provided solely for information purposes. You acknowledge there is no guarantee that transactions can be executed at such rates, and in certain circumstances your right to redeem may be restricted;
2. You acknowledge that you should seek professional advice if you are uncertain of or has not understood any description and/or terms and conditions in the Financial Report, Explanatory Memorandum and/or Prospectus (and/or other similar documents) or the nature and risks involved in trading of the fund(s);
3. You acknowledge that your investment decision is based on your own judgment without relying on advise given by BOOM or its representatives or any materials other than the Financial Reports, Explanatory Memorandum and Prospectus (and/or other similar documents) as is that subject to the provisions of the Articles of Incorporation of that fund company;
4. You understand in the event that the relevant fund house(s) refuse to accept any application for fund(s) (which you acknowledge that it/they is/are entitled to do), any investment money held will be released to your account with BOOM;
